Resident Single Operator with Multiple Business Licenses Required

Businesses providing additional services operating from the same physical address as the main business are required to purchase separate business licenses for each operation on an annual basis

First Business license \$50.00 and \$25.00 for each additional business license for additional services operating from the same physical address as the main business - does not apply to vending machine, cottage industry licenses or non resident business licenses

OTHER FEES

Transfer of license when place of business changes \$ 10.00

B. Each additional webpage listing by category -Annual Charge \$ 20.00

Individual business is responsible for all website design, maintenance updates, and storage costs

File Upload Fee per upload \$ 10.00

Minor Text Changes per request \$ 6.50

Major Text and Display Ad Revision \$ 20.00

Display Ad Photo Changes per request \$ 12.00

F. Annual fee to rent advertising space at Seaplane Base and Government Wharf pier areas \$ 60.00

* Signs must comply with Village of Tahsis sign criteria as listed below:

* signs must be 24" wide x 18" high

* business must pay for all design, construction, and material costs of the sign

* Village of Tahsis reserves the right to restrict material, design, and content of the sign

* Village of Tahsis will install the sign

* **A business must have a current Village of Tahsis business license in order to qualify for A - F**

* Annual fees for A - F must be received by January 31st of each year or the business sign and/or website display ads will be removed from the Village of Tahsis Website
